Dear Parent / Carer

Request to use your child's fingerprint to access cashless catering payment system

Silverdale School would like to use your child's fingerprint as part of an automated (i.e. electronically operated) recognition system. This is for the sole purpose of allowing your child to use the cashless catering payment system to pay for food in school. Our cashless catering provider has made upgrades to their systems which means that we will need to scan the fingerprints of all students who want to be able to pay for their food in school in this way, even if they have previously been scanned.

Fingerprints are classed as 'biometric information' because they are part of a person's physical or behavioural characteristics and under the Protection of Freedoms Act 2012 (sections 26 to 28), we are required to notify each parent of a child and obtain the written consent of at least one parent before being able to use a child's biometric information for an automated system.

How does it work?

The automated biometric recognition system takes measurements of your child's fingerprint and converts these measurements into an encrypted template to be stored on the system. **An image of your child's fingerprint is not stored.** The encrypted measurements taken from your child's fingerprint is what will be used to permit your child to pay for their food.

What is school required to do?

The law places specific requirements on schools when using students' biometric information within an automated biometric recognition system:

- schools cannot use the information for any other purpose
- schools must ensure that the information is stored securely
- schools must tell parents what it intends to do with the information
- unless the law allows it, schools cannot disclose personal information to another person/body

For clarity, the only body that we may be required to allow access to the data store is CRB Cunninghams Ltd (provider of the cashless system). This may be necessary for them to maintain and update the system. Even then they cannot access individual fingerprint data which is encrypted at rest.

What do parents/carers need to do?

As stated above, to be able to use student biometric information, the written consent of at least one parent is required. However, please be aware that:

- consent given by one parent is overridden if the other parent objects in writing
- you can object to the proposed processing of your child's biometric information at a later stage or withdraw any consent you have previously given if you later change your mind
- all consent, withdrawal of consent or objection from a parent must be in writing.

Even if you have consented, your child can object or refuse at any time to their biometric information being taken/used. If a student objects to the use of their biometric information a school must not collect or use it.

Student objections do not need to be in writing.

We would appreciate it if you could discuss this with your child and explain to them that they can object to this process if they wish. We are happy to answer any questions you or your child may have. If you do not wish your child's biometric information to be processed by Silverdale School, or your child objects to such processing, the law says that we must provide reasonable alternative arrangements for students who are not going to use the automated system to pay for their food. The alternative access is via the use of a card or a PIN code.

If you give consent to the processing of your child's biometric information, please sign, date and return the attached consent form to Silverdale School. Please note that when your child leaves Silverdale School, or if for some other reason they cease to use the biometric system, their biometric data will be securely deleted.
